Applicants **renewing** their permit from 2016 must **also** pay an **annual seed assessment** of 11 cents per \$100 on gross seed sales **in Washington state** over \$10,000. An **additional** late fee of 15% of the assessment is due if the application is submitted after February 1, 2017.
