1. Must be listed in 40 CFR 152.25 (f) (1) as exempt in descending order of composition 4. Must be listed in Inert List 4A and/or 40 CFR 180.950 in descending order of composition
2. Requirement for products labeled for use on food or feed crops 5. Purpose in formulation (examples: binder, diluents)
3. Purpose in formulation (examples: herbicide, repellent, insecticide)

Active Ingredients - Components in formulation. Must be listed in 40 CFR as exempt and listed in descending order of composition.

- **Common Chemical Name and Chemical Abstracts Service (CAS) Number**– Required for all ingredients. If any ingredients are listed by the supplier's brand name, have the supplier submit a CSF and letter of authorization to the WSDA. Ingredients must be listed in 40 CFR 152.25 (f)(1) as exempt in descending order of composition.
- **Name of Supplier** – Include phone number or web site contact information on the form.
- **Chemical Name as Listed in 40 CFR 180 and the Specific Citation** – Required for all ingredients if product is labeled for use on food or feed crops. 40 CFR 180 is available on the Government Printing Office web site at <http://ecfr.gpoaccess.gov/cji/t/text/text-idx?c=ecfr&tpl=%2Findex.tpl>.
- **Function** – Include the reason for each ingredient. For example, cedarwood oil is a repellent.
- **Nominal Percentage** – List a specific value for each ingredient in the formulation. Do not list a range of values.
- **Total percentage of Active Ingredients.**

Inert / Other Ingredients - Includes all other ingredients in the formulation in descending order of composition.

- **Common Chemical Name and Chemical Abstracts Service (CAS Number)** – Required for all ingredients. If any ingredients are listed by the supplier's brand name, have the supplier submit a CSF and letter of authorization to the WSDA.
- **Name of Supplier** – Include phone number or web site contact information.
- **Chemical Name as Listed in Inert List 4A and/or 40 CFR 180.950 and the Specific Citation** – Required for all ingredients (except water) if product is labeled for use on food or feed crops. An explanation of the Inert Ingredients of Minimal Concern is available on the EPA web site at http://www.epa.gov/opprd001/inerts/section25b_inerts.pdf.
- **Function** – Include the reason for each ingredient. For example, water is a diluent.
- **Nominal Percentage** – List a specific value for each ingredient in the formulation. Do not list a range of values.
- **Total percentage of Inert Ingredients.**

Total Percentage of All Ingredients – Must equal 100%.
