

# Customer Inventory Form Instructions

The customer inventory form provides planning information for the program and the hazardous waste contractor. The active ingredient(s), total amount and container information are especially important. We do not send your name to the contractor, only the chemical information.

WSDA becomes the legal owner (generator) of the pesticide before it becomes a waste pesticide. WSDA is the only generator listed on all hazardous waste documents. Your name will not be on the manifest or on any documents sent to the disposal facility.

**Please fill out the form(s) as completely and legibly as possible (please print or type) and mail to the address on the bottom of the form. You may make as many copies of the form as is necessary. Call (360) 902-2056 if you need assistance.**

**Name and Address:** Your address, phone number and county are needed only on one form. A completed example form and a sample pesticide label are enclosed to assist you. Keep the bottom copy (yellow) for your records.

**Bags:** WSDA will send you clear plastic overpack bags at no charge so you may safely handle or transport any damaged or leaking containers and those made out of paper or glass. Mark how many of each size you want.

**Name of Product:** The name of the product on the label. Examples: Fred's diazinon 50, Pramitol 25E, Weed - B - Gone, General Weed Killer, etc.

**Manufacturer:** The name of the company that makes the product. Examples: Fred's Chemicals, Ortho, Miller, Vertac, etc.

**Active Ingredient(s):** This is usually on the front panel of the label. Many active ingredients have a short common name. Example: The active ingredient for Fred's diazinon 50 reads: Diazinon: O,O-Diethyl O-(2-isopropyl-6-methyl-4-pyrimidinyl) phosphorothioate. In this case "diazinon" is the common name and is all we need on the form. Some active ingredients do not have common names or they are not printed on the label, in those instances, we need the full chemical name.

**USDA # or EPA Reg. #:** The EPA Registration Number is on the label, usually in fairly small print. Normally, it is below the active ingredient statement or near the manufacturer's address. It may also be located near the bottom of a side or back panel. For example: The EPA Reg. No. for Fred's diazinon 50 is 99999-215-100 and is located below the active ingredient statement. Pesticides manufactured in the 1950's and 1960's do not have an EPA Reg. No., but should have a USDA Reg. No. Pesticides older than 1950 and adjuvants do not have a registration number.

**Total Amount:** The total amount of material in all of the container(s) listed on this line. Examples: 20 pounds, 19 gallons, 1 quart, etc.

**Form:** Mark whether it is a liquid or dry formulation. Mark liquid for aerosol cans and pressurized cylinders.

## Container Information:

**How many, size and type:** Examples: 5 gal. metal can, 2 x 50 lb. bags, 1 gal. plastic jug, 1 pint glass bottle, etc.

**Condition:** Please mark whether the container is in good or poor condition.
