**Active Ingredients** – List all ingredients in the formulation that claim to provide pesticidal activity in descending order of composition.

- **Common Chemical Name and Chemical Abstracts Service (CAS) Number**– Required for all active ingredients. Active ingredients must be listed in [40 CFR 152.25 \(f\)\(1\)](#).
- **Name of Supplier** – Include phone number or e-mail contact information.
- **Pesticide Function(s) Performed** – Include the pesticide function(s) performed by each active ingredient. For example, cedar oil is a repellent.
- **Nominal Percentage** – List a specific value for each active ingredient in the formulation. Do not list a range of values.
- **Total percentage of Active Ingredients.**

**Inert / Other Ingredients** – List all other ingredients in the formulation in descending order of composition.

- **Common Chemical Name and Chemical Abstracts Service (CAS Number)** – Required for all inert ingredients. Inert ingredients must be listed in Inert Ingredients Eligible for FIFRA 25(b) Pesticide Products available at [www.epa.gov/sites/production/files/2016-07/documents/section25b\\_inerts.pdf](http://www.epa.gov/sites/production/files/2016-07/documents/section25b_inerts.pdf)
- **Name of Supplier** – Include phone number or e-mail contact information.
- **Purpose in Formulation** – Include the purpose for each inert ingredient. For example, water is a diluent.
- **Nominal Percentage** – List a specific value for each inert ingredient in the formulation. Do not list a range of values.
- **Total percentage of Inert Ingredients.**

**Total Percentage of All Ingredients** – Must equal 100%.
