**Purpose of Checklist:**

The State Environmental Policy Act (SEPA), chapter 43.21C RCW, requires all governmental agencies to consider the environmental impacts of a proposal before making decisions. An environmental impact statement (EIS) must be prepared for all proposals with probable significant adverse impacts on the quality of the environment. The purpose of this checklist is to provide information to help you and the agency identify impacts from your proposal (and to reduce or avoid impacts from the proposal, if it can be done) and to help the agency decide whether an EIS is required.

**Instructions for Applicants:**

This environmental checklist asks you to describe some basic information about your proposal. Governmental agencies use this checklist to determine whether the environmental impacts of your proposal are significant, requiring preparation of an EIS. 7. Do you have any plans for future additions, expansion, or further activity related to or connected with this proposal if yes, explain.

*Yes, the success of the project will be determined by the results of WSDA's summer gypsy moth trapping program. WSDA will install and monitor gypsy moth traps (64 traps per acre) in the treatment area during the summers of 2013, 2014, and 2015.*

8. List any environmental information you know about that has been prepared, or will be prepared, directly related to this proposal.

*The Washington State Department of Agriculture will prepare an Environmental Assessment (EA) which will be tiered to a Final Supplemental Environmental Impact Statement (FSEIS) prepared by the USDA-Forest Service and USDA-Animal and Plant Health Inspection Service entitled "Gypsy Moth Management in the United States: a cooperative approach, 2012" (FSEIS). Relevant sections of the FSEIS will be incorporated herein by reference. Copies of the EA and FSEIS will be available for review at the Washington State Library, 6880 Capitol Blvd. S, Tumwater, WA. The USDA is taking part in Endangered Species Act Section 7 consultation with both the United States Department of Interior Fish and Wildlife Service (USFWS) and the National Marine Fisheries Service (NMFS).*

9. Do you know whether applications are pending for governmental approvals of other proposals directly affecting the property covered by your proposal? If yes, explain.

*No*

*The above mentioned Environmental Assessment (EA) which will be tiered to the FSEIS.*

*WSDA will work with local governments to ensure compliance with all applicable local ordinances (Critical Areas Ordinance, etc.)*

*WSDA will consult with other agencies in order to implement appropriate mitigating measures with regard to Threatened or Endangered species and high quality ecosystems. Also, the Endangered Species Act Section 7 consultations being conducted by USDA.*

*WSDA will be working under NPDES permit #WA0039047 issued by the Department of Ecology to WSDA for the purpose of invasive moth control. The permit, titled "Invasive Moth Control National Pollutant Discharge Elimination System Waste Discharge Permit", authorizes discharge of insecticides into surface waters of the state of Washington that are consistent with the terms and conditions of this permit for the purpose of invasive moth control.*

11. Give brief, complete description of your proposal, including the proposed uses and the size of the project and site. *WSDA proposes to eradicate an infestation of gypsy moth in King County, Washington through implementation of two separate actions:*

*A) Three to five ground based applications of the biological insecticide Bacillus thuringiensis var. kurstaki (Btk) (Foray XG EPA Reg. No. 73049-46 or similar) will be applied to all foliage (according to label) within an area of approximately 10.5 acres. Bond Max (or similar), an adjuvant with spreader/sticker qualities may be utilized on ground treatments. The exact timing of the Btk applications will depend on the weather as well as larval and foliage development. Btk treatments would likely begin in late April or early May 2013.*

B) *A single aerial application of Disparlure (Disrupt II, EPA Reg. No. 8730-55), a synthetic version of gypsy moth pheromone used to disrupt mating behavior, will be applied to 181 acres. The sticker Micro-Tac may be utilized with the aerial application. The Disparlure application, which targets the adult gypsy moth, will be timed to occur shortly before adult moths emerge. The most likely application time would be early July 2013.*

*More than 45%*

*The site is predominantly urban. The underlying soil is best classified as "silt loam" or a soil consisting of a friable mixture of varying proportions of clay, silt, and sand.*

*Yes. The Tukwila sensitive areas map identifies an area in the treatment area as "Classification 4; very high landslide potential".*

e. Describe the purpose, type, and approximate quantities of any filling or grading proposed. Indicate source of fill.

*Mating disruption product will be applied to trees and shrubs from aircraft only. No on-the-ground activities will be conducted in areas of high erosion or landslide potential.*

## 2. Air

a. What types of emissions to the air would result from the proposal (i.e., dust, automobile, odors, industrial wood smoke) during construction and when the project is completed? If any, generally describe and give approximate quantities if known.

*WSDA will use trailer mounted spray equipment (gas powered) towed by diesel powered vehicles during the ground application of Btk resulting in some emissions. Some spray droplets will be suspended in the air for a short time during application.*

*Fixed wing airplane or helicopter will apply dispersure from a height of approximately 200 feet above treetops. Dispersure flakes will not remain suspended for any measurable time.*

b. Are there any off-site sources of emissions or odor that may affect your proposal? If so, generally describe.

*No*

c. Proposed measures to reduce or control emissions or other impacts to air, if any:

*Btk treatments will be limited to times when conditions do not promote prolonged droplet suspension.*

*Use of power equipment, vehicles, and aircraft will be temporary and limited to time required to effectively apply products.*

## 3. Water

*Yes, the Green River runs through the proposed treatment area and there is a small pond at Fort Dent Park. There are two unnamed wetlands just east of Fort Dent Park (within Renton city limits).*

2) Will the project require any work over, in, or adjacent to (within 200 feet) the described waters? If yes, please describe and attach available plans.

*Yes. Host vegetation adjacent to the described water bodies will be treated with Btk, dispersure, or both. Any overhanging host vegetation will also be treated*

*The Department of Ecology has issued WSDA an NPDES permit (refer to Section A, item #10 of this SEPA checklist). The permit and fact sheet may be viewed on the Department of Ecology web site at [www.ecy.wa.gov/programs/wq/pesticides/final\\_pesticide\\_permits/invasive\\_moth/mothfinalpermit.pdf](http://www.ecy.wa.gov/programs/wq/pesticides/final_pesticide_permits/invasive_moth/mothfinalpermit.pdf). WSDA and its contractors for this proposal will comply with all terms and conditions set forth in the NPDES permit.*

3) Estimate the amount of fill and dredge material that would be placed in or removed from surface water or wetlands and indicate the area of the site that would be affected. Indicate the source of fill material.

6) Does the proposal involve any discharges of waste materials to surface waters? If so, describe the type of waste and anticipated volume of discharge.

A) *Ground-based Btk treatment:*

*Some pesticide residue could enter surface water as a result of spraying overhanging vegetation. Precision spraying equipment will minimize the likelihood of material entering the water. WSDA will comply with the terms and conditions of the above mentioned NPDES permit.*

B) *Aerial Disparlure treatment:*

*Applicator must comply with label Directions for Use which states, "do apply directly to water or areas where surface water is present". The product will be applied with a sticker that binds the flakes to the foliage. Some residue could enter surface water as a result of spraying nearby vegetation. WSDA and its contractors will comply with the terms and conditions of the above mentioned NPDES permit.*

b. Ground:

*Storm water drains populate the proposed treatment area. The storm drains feed runoff to the Green/Duwamish River.*

*Possibly*

d. Proposed measures to reduce or control surface, ground, and runoff water impacts, if any:

*Due to the timing of applications and precision of ground spray equipment, it is unlikely that any material would enter the storm water system. The mating disruption product (disparlure) will be applied with a sticker intended to adhere the flakes to the tree canopy and vegetation. To maximize product efficacy and to minimize potential runoff, no applications (Btk or disparlure) will be conducted when it is raining or when rain is in the immediate forecast.*

*A search of the Washington State Dept. of Natural Resources Natural (DNR) Heritage Information System found no records for rare plants or high quality native ecosystems in the vicinity of this project. It is not anticipated that any threatened or endangered species will be affected by this proposal.*

- d. Proposed landscaping, use of native plants, or other measures to preserve or enhance vegetation on the site, if any:

*The gypsy moth feeds on more than 500 different species of trees and shrubs. Establishment of the gypsy moth in Washington State would seriously damage our environment, economy, and quality of life. WSDA's measures to eradicate gypsy moth will preserve native plants, landscaping, and other vegetation.*

*The information provided by WDFW Priority Habitats and Species Program did not identify any state listed threatened or endangered species at or near this site. The Green River runs through the proposed site. WDFW lists the presence of priority anadromous fish including coho salmon, sockeye salmon, pink salmon, fall Chinook, fall chum, winter steelhead, summer steelhead, and bull trout. Resident cutthroat is the priority resident fish presence listed by WDFW for the Green River.*

- c. Is the site part of a migration route? If so, explain.

*Yes, Pacific flyway for migrating birds.*

- d. Proposed measures to preserve or enhance wildlife, if any:

*WSDA will coordinate with other agencies in order to implement any appropriate mitigating measures with regard to the previously mentioned species. It is not anticipated that any threatened or endangered species will be adversely affected by this proposal as none are expected to be in the treatment area at the time of application. WSDA's measures to eradicate gypsy moth will preserve native plants, landscaping and other vegetation, thereby protecting the habitat needed by wildlife.*

*Yes, exposure to the insecticide during mixing and application, and some potential for spills. The potential for health hazards associated with this project are addressed in the FSEIS referred to in Section A, item #8 of this SEPA checklist. According to the FSEIS, there is minimal potential for significant adverse impacts on human health in projects of this type. It is the intent of the WSDA to reduce that minimal potential through compliance with the label, and actions detailed in #2 below.*

1) Describe special emergency services that might be required.

*Some potential need for the Dept. of Ecology "spill response" in the event of a major spill.*

2) Proposed measures to reduce or control environmental health hazards, if any:

*Mixing and application of insecticide will be done in accordance with the label and only under the supervision of WSDA monitors. Containment and clean-up materials will be on-site during applications. Interested stakeholders will be supplied with information about the materials to be applied. Stakeholders will also be given the opportunity to be placed on a call-ahead list and notified of dates and times of activity and of measures they may wish to take to protect themselves and their property.*






